Join the Countywide Community Revitalization Team (CCRT) meeting hosted by the Office of Community Revitalization (OCR) on Tuesday, May 9, 2023, at 10 a.m.

The meeting will be held both virtually and in person at the Vista Center Hearing Room 1E-60, 2300 N Jog Rd., in West Palm Beach. The virtual meeting can be accessed through the link below or via conference call.

CCRT members and OCR staff will provide updates on projects currently underway and/or planned to address community needs.

Merlene Ramnon, Ph.D., Director, of Community Health Promotion and Education, Florida Department of Health, Palm Beach County, will be in attendance to talk about the Department of Health's Fetal Infant Mortality Review (FIMR) Program. FIMR is a process of community-based fetal and informal mortality reviews aimed at addressing factors and issues that affect infant mortality and morbidity. The purpose of the program is to understand how a wide array of social, economic, health, educational, environmental, and safety issues relate to fetal and infant loss at the local level, and utilize that information to improve community resources and systems of care to lower fetal and infant mortality.
