League to address African American history education standards

'We are planning to address these misleading offensive statements as the League on our own, and in concert with many historical groups that educate on African American history.'

One of the recent challenges in Florida is the newly announced standards of African American History established by a Florida Department of Education board. These standards include a curriculum that claims slavery actually taught slaves skills that some were able to use for their own benefit. This is an outrage! The League will not quietly let this pass by.

We are planning to address these misleading offensive statements as the League on our own, and in concert with many historical groups that educate about African American history, see the connection between erasing the history of minority groups and limiting the participation of minority groups in civic engagement.

EDUCATION ADVOCACY GROUP LAUNCHES PETITION



In July, the Florida Board of Education passed African American History standards for grades K-12. These standards aim to teach the rich and complicated history of African Americans. This approval is just the start of a work in progress. The FLBOE has its next meeting on Aug. 23, and Families for Strong Public Schools is requesting the following be changed and/or added to the current standards:

1. Change the language of standards to address that enslaved people did not benefit from being enslaved.

2. Create and include standards that teach the history of the African diaspora to properly reflect the history of African peoples.

3. Create and include standards that teach about the African American experience post-1965 to the modern day.





The national League is moving at full speed with National Popular Vote. Its plan is part of a multi-decade effort, the goal of which is election of the U.S. President and Vice President by popular vote.

And **Kathleen Crampton**, from LWVPBC and Chair of Floridians for National Popular Vote, was instrumental in guiding everyone along. The result was even bigger than these champions imagined.

Election workers play an essential role in our democratic process. They assist with everything from setting up voting machines to ensuring voters have a smooth and positive experience at the polls. Dedicated election workers help ensure successful elections. We want Palm Beach County to continue to be recognized as having one of the best election experiences in the state, and that will take all of us working together to achieve that.

Election workers are paid positions and provide an opportunity for individuals to earn a little extra money while fulfilling their civic duty. Pay ranges from \$190 to \$375, depending on the election worker's position. We also offer community service hours.

We provide comprehensive training for all election workers to ensure they are well-prepared for their roles, and we will make every effort to accommodate their preferences so they can serve at a location near their home.

YOU SAID IT: Staying on Low Road for Florida Court System

Palm Beach County League member Ira J. Raab of West Palm Beach is a retired justice of the New York State Supreme Court. The Palm Beach Post published his Opinion column on Aug. 13.

Gerrymandering is the deliberate manipulation of electoral district boundaries by a political party to achieve an unfair advantage over rivals.

In Florida, the political party in power redraws district lines every 10 years, after the federal census. Drawing district lines for the Florida House and Senate is done by the Florida Legislature, subject only to Florida Supreme Court review. Florida's Congressional districts, by contrast, are subject to veto by the governor, which can be overridden only by a vote of two-thirds of each legislative chamber.

LEAGUE SUPPORTING TWO PETITION DRIVES: ABORTION ACCESS AND CLEAN WATERS IN FLORIDA **By Phyllis Applebaum**, *Voter Services Chair* We have already been collecting petitions for the Abortion Access constitutional amendment proposed by Floridians Protecting Freedom, and have recently begun collecting petitions for the Right to Clean and Healthy Waters as well.



Even though SB 7050 has mandated restrictions on our voter registration activities after July 1, there are no restrictions on gathering petitions, nor on gathering Vote by Mail applications. A reminder that only petitions signed by registered Florida voters will be accepted.


Founded in 2017, Fort Circle Games designs board games based on historical events. Fort Circle Games is based in Washington, D.C., and is named after the network of fortifications that


